#### **Risk**Credits

The claims frequency in Ireland has highlighted the importance of Continuing Professional Development (CPD) for dental professionals. Although CPD is not yet mandatory in Ireland, the Dental Council's Code of Practice relating to *Professional Behaviour and Ethical Conduct* states that all dentists have an obligation to maintain and update their knowledge and skills through CPD.

Dental Protection has developed the **Risk**Credits scheme to acknowledge the benefits of CPD – focused on risk management. The idea of the scheme is to provide a discount to those members who engage with Dental Protection qualifying activities.

**Risk**Credits are awarded for Dental Protection approved risk management CPD. carried out in the previous membership year. Please note you can only use CPD hours to count towards RiskCredits once and CPD must have been carried out in the previous 12 months of membership.

1. **Risk**Credits will be awarded for **every hour** of certified risk management CPD declared from the options on our online learning hub. You will need to complete **3 hours** of mandatory learning topics, and a further **7 hours** of learning relevant to your practice.

### **Qualifying activity**

**Risk**Credits can be earned by completing Mandatory and Optional learning modules. Mandatory modules have been selected based on trends seen in complaints, cases and claims, these must be completed annually to qualify for a RiskCredit discount.
